- A few of the projects discussed were the Clark Regional Airport's land acquisition and expansion, new manufacturer Clean Control's line expansion, Interstate Inn motel's 13 million dollars renovation and remodeling project, Tarleton's Convocation Center and Research & Development Building, and the groundbreaking at Bosque River Tap House on Harbin Drive and Swan.
- An update was given highlighting SEDA's involvement in a variety of local, rural, and statewide events such as: Local Industry Social, SHS Career Club/Academy, Texas Workforce Commission Annual Conference, and the North Central Texas Workforce Solutions Accelerator session.
- A schedule of upcoming events was highlighted: ICSC Las Vegas (recruiting event), TEDC midyear conference and ED Suite's community photo shoot.
- A facility update was provided, notifying the board that final construction documents were gathered by City Hall and an RFP will be posted.
- President Sandford shared details related to the Harbin Drive infrastructure improvement project.
  Items discussed were the re-naming of Harbin Drive to University Drive, design and irrigation
  issues, and a change to the original proposed greenspace improvements associated with the
  medians. Specifically, there was discussion and concerns raised over the decision to replace
  greenspace with hardscapes on the medians, and the potential negative impact that might have on
  future local development.
