I. Call to Order.

II. Staff Report

- The President started the meeting with an update on the Entrepreneurs of Erath competition that SEDA financially
 supports. The competition was slated to start the following week and has had over 30 applications submitted.
- President Sandford also reported that Washington Commons continues to attract consumer spending.
 The City received their first sales tax report that showed an increase in revenue, with only a handful of the stores open at this time.
- ICSC Red River was a successful event for SEDA. Stephenville is on the map as being open for business and staff had 14 meetings within 24 hours. Several follow ups were scheduled for the ICSC Re Con event to be held in May.
- President Sandford updated on The Stable development and the strides being made with dirt work, drainage, and
 infrastructure grade work. Sandford reported that the first two sites are to be turned over to Chick Fil A and McAllister's at
 the beginning of summer.
- President Sandford updated the Board on several of the projects making visual progress. The façade grant at University Plaza and the water line extension for the second Tractor Supply location.
- In closing, President Sandford reminded the Board that several large expenditures would be noticed on the financial report, quarterly payments for Retail Coach, ED Suite and SLP partnership.
